**Government Order No. 12 – JK(TR) of 2024
Dated: 19 -03-2024.**

Sanction is hereby accorded to the Constitution of Committee comprising of the following composition for Installation of Rooftop Solar Power Plants on all the Government Buildings of the Transport Department within the stipulated time period: -

1. Director Finance, Transport Department.
2. Joint Director (E&S), Transport Department.
3. Representative of JAKEDA/NHPC as co-opt member for technical advice.
4. Representative of DISCOM.

The terms of reference:-

1. The committee shall monitor and supervise the mission of solarization of all Government Buildings in the Transport Department for accelerating the solarization process, so as to attain saturation by or before December, 2024 as directed by the Prime Minister's Office (PMO).
2. The Committee shall advice on innovative ways for resource mobilization for successful implementation of the project in RESCO/Capex/Hybrid modes. They shall also suggest source of funding through Finance Department/MNRE and other Funding Agencies like REC/ other Financial Institutions.
3. The Committee shall identify viable buildings and collect all major parameters like availability of rooftop and evacuation network, the total electricity load, sanctioned connected load as well as revenue budget spent on electricity bills be shared with JAKEDA.
4. The Committee shall nominate Estates officers/In-charge officers for major Buildings, where RESCO/Capex/Hybrid model shall be implemented.
5. The progress of the Solarization shall be shared on fortnightly basis to the Science and Technology Department/JAKEDA.
